Students wishing to represent Canada in the competition must send a YouTube video of a prepared classical variation, (see attached list), a contemporary dance (maximum three minutes in length), and the relevant set Cecchetti Port de Bras, (first set for junior, second set for Senior), plus a moving allegro step (allegro #9 from the intermediate syllabus, demi-contretemps etc., for junior, and allegro #10 glissade assemblé etc., for senior), **by January 15, 2020.**

The panel will notify applicants of their decision **by January 30, 2020.**

Please note the following:

- 1) The video should be labelled "2020 Cecchetti International Classical Ballet competition" followed by your full name.
- 2) In the description of the video, please give your full name (as listed on the application) and any other relevant information you wish to share.
- 3) It is recommended that the privacy settings be set to "Unlisted" (or the equivalent) so that the video is not publically available, but can be seen by anyone you choose to share the link/URL with.
